# THE PRIORITY PROJECT

Calling on Property Investors to help the fight against DFV

A ground-breaking pilot project right here in Brisbane will provide a practical solution to the critical problem of homelessness and Domestic Violence – and rental property owners can now make a huge positive impact.

#### **A Community Crisis**

Domestic and family violence (DFV) is the leading cause of homelessness for women and children in Australia.

The current limited supply of rental properties across Queensland presents an unacceptable risk for women and children who are choosing to remain in unsafe living situations due to a lack of suitable housing.

While there is a clear need for more short-term crisis accommodation and social housing, there is also the opportunity to house vulnerable women in medium to long term tenancies in private rentals – properties such as yours.

### **Introducing The Priority Project (TPP)**

TPP is an initiative of The Constellation Project and is proudly supported by The Real Estate Institute of Queensland, PwC, Mission Australia and The Salvation Army.

TPP is a proposed solution to help women and their children experiencing DFV to secure housing and avoid homelessness through a Property Register. Properties are added to the Property Register with the willingness and intent to prioritise tenants who are impacted by DFV.

#### **TPP & Solutions Property Management**

We have been an integral part of the TPP working group since its inception and are the chosen agency for the 12-month pilot program, due to begin later this year.

I trust that many of our owner clients would welcome the opportunity to assist women and children in urgent need, especially when it does not impact on their income or investment. Note that all regular checks are done prior to placing tenants, and the owner makes the final decision. Studies suggest that a family fleeing DFV and placed in a safe rental home supported by social services is likely to maintain a successful long-term tenancy.
